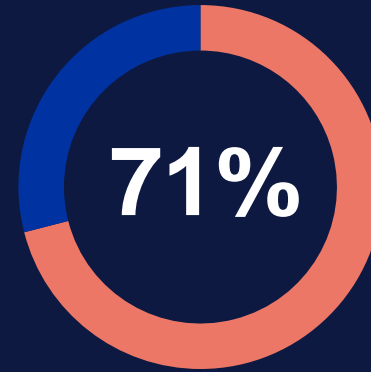

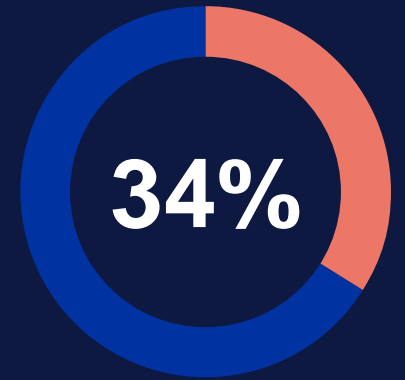

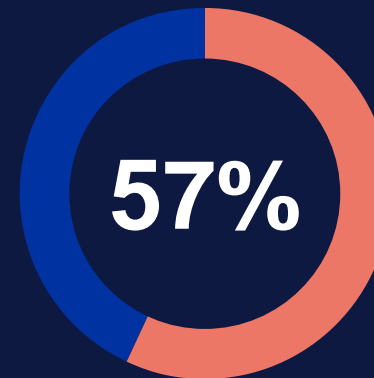
with an increase in remote working, employees and employers alike **face an even greater risk of falling victim to fraud**



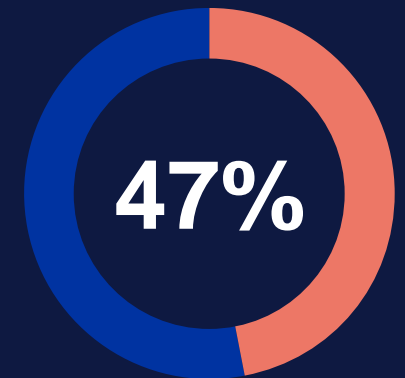
of employees were working from home full-time by December 2020
